Important things have happened since the last newsletter. From May 10-16, we had the first INA meeting. At the businees meeting associated with it, the possibilities of having another meeting were discussed, and some switches were thrown for the future development of INA Many of the applied for INA membership, and so the club has almost doubled. For these reasons, this newsletter is focussed on INA internal affairs, and contains on update of the INA database.

The 1st INA meeting:

Concluding from the many positive reactions it elicited, the late meeting in Lunteren (NL) was a big success. I have passed on all the credit, which was falsely given to me, to the brave local organizing committee who did a marvellous job. I also would like to acknowledge the valuable contribution from the chairpersons who put up an attractive scientific program and helped editing the abstract book and the proceedings. Not to forget sponsors, who alleviated substantially the financial burden and, hear, offered grants to young scientists who otherwise could not have attended.

The upcoming 2nd INA meeting:

Already at the end of the first conference day in Lunteren (no kidding), the question was raised if there could be another INA meeting under similar circumstances (except for the pouring rain). Luckily enough, after a while I got two and a half offers from groups who are willing to undergo the stressful task of organizing such on event. Leaving the choice up to the people who answered the questionnoire which was handed out at the I have now the pleasure to announce that the 2nd INA meeting will be held in Barcelona, Spain, in 1989. Whether or not it will be supplemented by a mini-symposium on the toxicology of primary sensory neurons is currently in the state of discussion.

Another issue touched by the questionnaire was the style of future INA out of 85 respondents want to see them in meetings. 82 countries, and one participant has even suggested to have it at the north pole. By contrast, only half of the respondents were happy with the following each presentation, and want more time sacrificed to oral presentations and poster demonstrations. Last not least, there is a chance that we might have an INA orchestra at the next meetings, as participants are playing an instrument. What a pity for the only one respondent who will not come again to an INA meeting!

Organizing a meeting starts by putting together a program, and by finding the persons who fit into it with their presentations. Also, a selection among the abstracts sent in by the participonts may have to be mode. And at the end of the meeting, somebody has to look after the proceedings. These are some of the reasons why INA needs a standing scientific committee. Among the many offers we got, Jakob and I selected 8 names. It was our aim to gather people from different regions of the world, who represent some of the vorious disciplines INA members work in. One seat was given to Dr. Rodriquez Farre, who is the representative of the local organizing committee in Borcelono. And here is the complete list:

The outcome from the business meeting:

Besides the more important things mentioned before, some humble problems of everyday club-life were also discussed in Lunteren. It was stated, for instance, that INA will not be officially registered within the next 2 years, and that it will not try to become part of a bigger society. Jakob Hooisma will serve as a secretary to the scientific committee, while I will go on issuing newsletters, keeping the INA database, and taking care of the continuation of INA.

As INA asks no regular membership fees, but still has some expenditures like making xeroxes or buying office material and stamps, the question of funds had also to be discussed. As a result, I have opened a special account which is meant to be nourished from the donations I will get from all people who like my newsletters and database. Another source of money will be the initial fee charged from new members, which was set to 30 Deutsche Mark (about 15\$) for the time being. As this decision was only made at the end of the Lunteren meeting, this new rule does not apply to those who applied for membership during the meeting, but only to post-Lunteren applicants. If there is a surplus at the end of the year, it will be transferred to the account in Holland which holds the money for the organisation of the next conference. And here is the account number:
